There is a requirement that states 40 hours of PTO must remain in their bank prior to selling, and only 40 hours of PTO are allowed to be sold at the end of the year (December). The recommended policy allows the employee to sell up to 24 hours due to hardship at any time, and still keep up to 40 hours in their personnel bank.
