Your Annual Report on Water Qualify for 2023

The City of Taft Water Department is providing this annual Drinking Water Quality Report to tell you about how its water quality compares to the guidelines set by the U.S. Environmental Protection Agency (EPA). All drinking water providers are required by federal law to issue an annual quality report like this one to their customers.

Most importantly, the Water Department wants you to know that when you drink tap water from our system, you are drinking clean, high-quality water that meets strict government standards. This report will help you understand the steps taken every day by our experienced staff to deliver the safe drinking water that is essential to human survival.

Many people are surprised to learn that all drinking water, even bottled water, is likely to contain some level of contaminants. The presence of the contaminants does not necessarily mean that the water poses a health risk. Many constituents (such as calcium sodium, or iron) which are often found in drinking water, can cause taste, color, and odor problems. These are called "secondary constituents" and are regulated by the State of Texas, not the EPA. These constituents are not causes for health concern. Therefore, they are not required to be reported in this document, but they may affect the appearance and taste of your water.

Definitions

Action Level Goal (ALG): The level of a contaminant in drinking water below which there is no known or expected risk to health. ALGs allow for a margin of safety.

Action Level: The concentration of a contaminant which, if exceeded, triggers treatment or other requirements.

Avg: Regulatory compliance with some MCLs is based on running annual average or monthly samples that are taken.

Maximum Contaminant Level or (MCL): The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

Maximum Contaminant Level Goal or (MCLG): The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

Maximum Residual Disinfectant Level or (MRDL): The highest level of a disinfectant allowed in drinking water. There is evidence that addition of a disinfectant is necessary for control of microbial contaminants.

Maximum Residual Disinfectant Level Goal or (MRDLG): The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.

Sources of Drinking Water

The sources of drinking water is purchased surface water from the San Patricio Water Municipal Water District which comes from Lake Corpus Christi, Choke Canyon Reservoir and Lake Texana. Source water for both tap water and bottled water include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Potential contaminants include:

- Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations and wildlife
- Inorganic contaminants, such as salts and metals, which can be naturally occurring or result from urban storm water runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming
- Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban storm water runoff and residential uses
- Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production and can also come from gas stations, urban storm water runoff and septic systems
- Radioactive contaminants, which can be naturally occurring or be the result of oil and gas production and mining activities

In order to ensure that tap water is safe to drink, EPA prescribes regulations, which limit the amount of certain contaminants in water provided by public water systems. FDA regulations establish limits for contaminants in bottled water, which must provide the same protection for public health. Contaminants could be found in drinking water that may cause taste, color, or odor problems. These types of problems are not necessarily causes for health concerns.

2023 Annual Drinking Water Quality

To protect public health, the EPA has identified acceptable level for constituents in tap water. The TCEQ has assessed our water system and determined that our water is safe to drink. All constituents in our water are well below the federal and state maximum containment levels. The following table contains the chemical constituents found in drinking water coming the San Patricio Municipal Water District water filtration and treatment complex located between Gregory and Ingleside. The EPA requires all water systems to test for up to 97 constituents.

Revised Total Coliform Rule (RTCR)

The Revised Total Coliform Rule (RTCR) seeks to prevent waterborne diseases caused by E. coli. E. coli are bacteria whose presence indicates that the water may be contaminated with human or animal wastes. Human pathogens in these wastes can cause short-term effects, such as diarrhea, cramps, nausea, headaches, or other symptoms. They may pose a greater health risk for infants, young children,

Health Information for Lead

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. We are responsible for providing high quality drinking water, but we cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to two minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. The City of Taft has violated the monitoring and reporting requirements set by Texas Commission on Environmental Quality (TCEQ) in Chapter 30, Section 290, Subchapter F. Even though these were not emergencies, as our customers, you have the right to know what happened and what we are doing (or did) to correct these situations.

We are required to monitor your drinking water for specific contaminants on a regular basis. Results of regular monitoring are an indicator of whether or not our drinking water meets health standards. During 01/01/2021 through 12/31/2024 we did not monitor or test for contaminant(s) and therefore cannot be sure of the quality of your drinking water during that time.
